OPPO Lucky Draw Terms and Conditions of Home Credit India Finance Private Limited

These terms and conditions apply to the OPPO Lucky Draw (hereinafter referred to as "Lucky Draw") sponsored by Home Credit India Finance Private Limited (hereinafter referred to as "Home Credit") and OPPO Mobiles India Private Limited (hereinafter referred to as "OPPO"), wherein the eligible customers of Home Credit shall have an Opportunity to win OPPO Enco W11 worth INR 2499/- each. Home Credit and Oppo shall together be called as Organizers.

By participating in the Lucky Draw, the customer(s) fully and unconditionally agree(s) to accept and abide by the terms and conditions of OPPO Lucky Draw hereinafter specified (referred as " **OPPO** Lucky Draw Terms and Conditions of Home Credit" and available on <u>www.homecredit.co.in</u>).

- ii. Home Credit reserves the right to exclude any person from the Lucky Draw at any time on the grounds of him/her being the subject of criminal investigation or due to misconduct/ misbehave or criminal record or conviction of any crime.
- iii. Employees, agents and representatives of Home Credit, its advertising and promotional agencies, suppliers of prizes, material and services related to this Lucky Draw, as well as members of their immediate families (brothers, sisters, children, spouse and parents) are not eligible to participate in Lucky Draw.

- ii. There will be 2 lucky winners every day in the lucky draw result which shall be announced by Home Credit. The quantity is fixed for 2 prizes per day. All the lucky winners will get OPPO Enco W11 worth INR 2499/- each prize during Lucky Draw Offer Period mentioned above.
- iii. The Lucky draw winners will be announced and informed within 10 days from the day of purchase and the gifts will be dispatched by OPPO at the residential address of the winning customer within 15 days from the date of announcement.
- iv. The Winners shall be selected through a lucky draw and the names of the winning customer's shall be announced on the social media channels and website of Home Credit. The winners will be shortlisted in Lucky Draw through an electronic draw made on random basis by Home Credit.

- v. The Winners shall be announced on all the platforms i.e., Social Media, via Dealer and Network touchpoints including whatsapp groups, sticker etc.
- vi. Each customer shall be eligible to participate only once in Lucky Draw.
- vii. Home Credit shall communicate the winning customers either by phone call on their mobile number registered with Home Credit or by sending e-mail at registered e-mail id of the customer available with Home Credit, as may be decided by Home Credit. 3. Indemnification

 - iii. Neither, Home Credit nor any of its Affiliates shall be liable to perform any of its/their respective obligations under the terms and conditions of this Lucky Draw or in respect of the prize where it is unable to do so as a result of circumstances beyond its/their control in the nature of explosions, natural calamities, state emergency, riots, or any other Force Majeure condition etc.
 - iv. Home Credit shall not be liable to compensate the customers in the above-mentioned circumstances and shall not be accountable/ liable for any disruptions/ stoppages/ interruptions or cancellation of the OPPO Lucky Draw.
 - v. Home Credit, its employees, representatives or agents, will not be responsible for any NDNC (National Do Not Call) Registry regulation that comes into play. 4. Dispute Resolution

- i. Every dispute, difference, or question which may at any time arise between the parties hereto or any person claiming under them, touching or arising out of or in respect of these terms and conditions of Lucky Draw or the subject matter thereof shall be referred to the sole arbitrator to be appointed by Home Credit for arbitration in the territory of Gurugram (Haryana, India) as per the provisions of the Arbitration and Conciliation Act, 2015 with such modification and amendments as may be in force for the time being and the decision of the arbitrator shall be final and binding on the parties.
- ii. In spite of the aforesaid, the participants agree that the Organizers, in their sole and absolute discretion, reserves the right to provide alternative prizes to the winners for an equivalent value, if such winner is not disqualified as per the Terms mentioned herein. The participants and winners expressly agree that no claim shall be made against the Organizers, if alternative prizes of an equivalent value are provided and acknowledge that no participant shall be entitled to more than one prize for this Lucky Draw.

All dispute arises between the Parties relating to application, interpretation, implementation or validity of this Lucky Draw shall be governed and construed in accordance with the laws of India. intimation/notice of any kind and will not be liable for any consequential losses/damages. Any decision of Home Credit in this regard and in general with respect to this Lucky Draw and the terms and conditions thereto shall be final and binding.

- iv. The decision of Home Credit shall be final in all regards and no communication shall be entertained in this regard. None of the provisions of these Terms and Conditions shall be deemed to constitute a partnership or agency between any customer and Home Credit and the customers shall not have the authority to bind Home Credit in any manner whatsoever.
